iv. DIRECTORS UPDATE

Campus Update:

Here in April things are changing; we have hit every season in a week! Families have been invited to check out our lost-and-found which has now been cleared, washed, and moved to a collection bin. The VIP fundraiser was a success and our VIPs are taking their spot at the front of the line for drop-off and pick-up! Thank you everyone who so graciously donated.

We are getting a lot of medical calls due to the allergy season. Please remember we are not doctors, you need to call your primary care for guidance.

- Returning Update:

Next Monday, April 19, we will be following the Governor's executive order; our remote students will be invited back for in-person learning. For the most part, everyone will be in person with the exception of Wednesday, April 21, 2021 as a remote day due to staff vaccinations the previous evening. After vacation we will return to a 5-day in-person model. YMCA is in place at school for Wednesday after school care.

Cartwright adds to keep an eye out for policies to be approved at upcoming meetings such as Proof of Residency, Weapons on School Property, and Student Discipline policies.

March Financial Statements:

We are in line with our budget and are observing an increase in the revenue compared to last year due to the number of students we have enrolled. Revenue items under budget include fundraising. Over budget items include special education and donations to the school. Cartwright notes "the deficit in fundraising has not negatively affected us as it should have because we were able to pick up some of our expenses in our last fiscal year". There was an unexpected expense for Title-1 materials. However, we will be reimbursed \$32,000 for those materials. We are solid and have not needed to draw on our line of credit. The final 10% payment from our unrestricted grant from the state comes in at the end of June. Donations from the month of March include Proto Part Inc. (\$200), dressdown/staff donations (\$306.79), Benevity Community Impact Fund (\$1.46), and Lands End (\$968.50). Totaling \$1,476.75. The PTO Fund balance stands at \$3,630 and the Uniform Assistance Fund has a balance of \$1,599.

Salaries Tab for FY 2022:

We do need to vote on salaries and hourly wage expenses as a part of the overall fiscal year 2022 budget. Cartwright notes "the reason we are going through this portion of the budget this evening and not waiting until the budget is finalized is because our team has contract rollover. As everyone is aware, we will have more teachers next year with the addition of two more third grades and so on and so forth. So we don't get behind and can post those job listings, we need to find out which team members are returning or leaving. That is why you are not seeing the full budget laid out; it is just this one section"
